Roundtable Recent Case Law of the ECJ with a Special Focus on the Case COMBIT./.COMMIT

Last year, the ECJ again issued some very interesting decisions in the field of trademark law. Among these are several decisions relating to particular areas that – surprisingly – have not yet been clarified. The decisions of the ECJ in the field of EU trademark law are essential to all practitioners. These decisions can support them in their daily work and lines of argumentation.

This presentation will give an overview of some selected recent decisions that most likely will have an impact on the daily work of attorneys, corporate counsel, and those interested in trademarks. The presentation will discuss the decision C-223/15 COMBIT./.COMMIT in more detail, as this demonstrates problems that may result from the principle of unitary character of an EU mark. In particular, one question focused on will be how to handle injunctive relief if a likelihood of confusion is given in certain member states and not in others.
